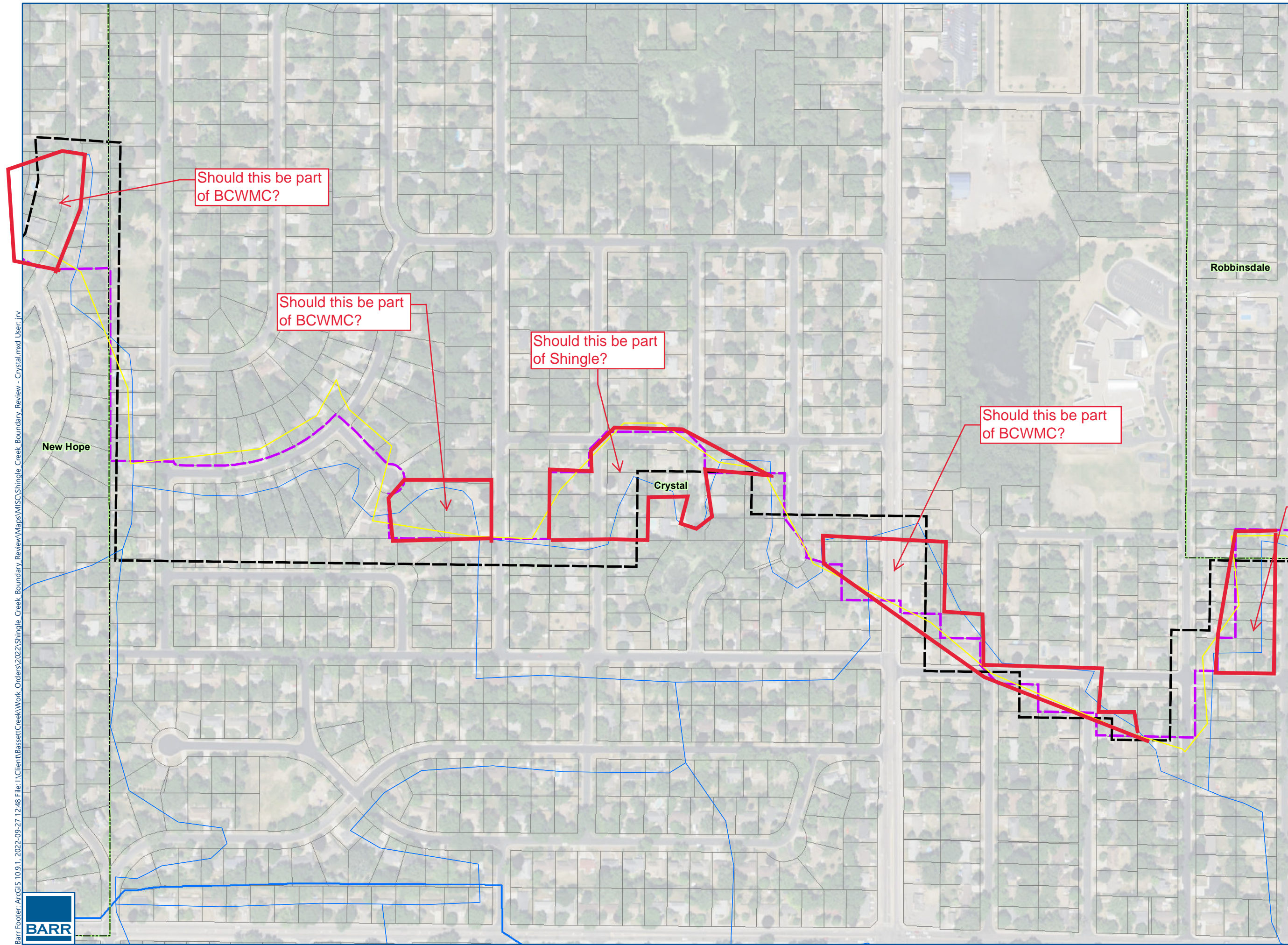
Boundary revised to reflect parcel boundary - historically parcel subdivided based on Hydrologic Boundary - now in BCWMC
